Rule 230(7) of GFRs states:

Unspent Balances: When recurring Grants-in-aid are sanctioned to the same Institution or Organisation for the same purpose, the unspent balance of the previous Grant should be taken into account in sanctioning the subsequent Grant. For this, purpose, the Programme Division of Ministries/Department shall take help of PFMS portal to know the bank balance of the recipients before making each release. The instructions of Department of Expenditure regarding the use of PFMS Portal for Central Sector Schemes issued from time to time shall be strictly followed by all Ministries/Departments. The principles of just in time release' should be applied for releases in respect of all payments to the extent possible. The following broad principles shall be adhered to:

- (i) Cash balance at a time should preferably not be more than 3 months of requirements.
- (ii) Funds should be released as per actual requirements and that sanction may precede the release of funds, though its validity may be limited to that financial year.

II. The unspent balance as per EAT Module with the organization is nil under ASPIRE with PPDC, Agra. The payment is being made 1st time to the Institute under ASPIRE Scheme.


